The candidate should be motivated and should have prior experience in experimental work involving pulsed laser systems.

**Job Description:** The works will be in the areas of (i) nonlinear optics focusing on pump-probe studies, and (ii) laser-produced plasmas.

**Remuneration:** A consolidated remuneration of Rs. 31,000/- per month plus HRA as applicable as per the norms will be paid to the selected candidates.

**Essential Qualifications:** (i) M.Sc. degree or Integrated M.Sc. degree in Physics, Photonics or Optoelectronics, (ii) Minimum six months' experience in pulsed laser based spectroscopy experiments.
